## Franchise / Authorized Learning Center Policy

### 1. Introduction

OHM College of Astrological Sciences & Research Centre - Global aims to expand structured and authentic astrology & allied education through qualified and experienced astrology professionals by establishing Authorized Learning Centers under centralized academic supervision of the Head Office (HO). This collaboration enables experienced astrologers to conduct professional astrology courses while maintaining standardized curriculum, assessment methodology, and certification quality across all authorized centers.

### 2. Franchise Models

#### A. Online Authorized Teaching Partner

**Franchise Fee:** ■50,000 (One-Time)

**Scope:**

- Franchisee shall conduct astrology & allied classes in online mode only.
- Franchisee will arrange and enroll students independently through self-marketing efforts.
- All academic delivery shall strictly follow curriculum approved by Head Office.

**Responsibilities – Franchisee:**

- Student marketing and enrollment generation
- Conduct online teaching as per approved syllabus
- Maintain attendance and academic discipline

**Responsibilities – Head Office:**

- Admission confirmation
- Fee collection through official HO account
- Student database management
- Examination & assessment supervision
- Certification issuance

**Revenue Sharing:**

60% Franchisee : 40% Head Office (after applicable deductions)

#### B. Offline Authorized Learning Center

**Franchise Fee:** ■1,00,000 (One-Time)

**Scope:**

- Franchisee shall establish own classroom or institutional setup.
- Teaching may be conducted in Offline, Online, or Hybrid mode.
- Infrastructure and operational expenses shall be borne by Franchisee.

**Responsibilities – Franchisee:**

- Classroom setup and maintenance
- Local promotion and student enrollment
- Conducting classes as per HO academic guidelines

**Responsibilities – Head Office:**

- Admission approval
- Fee collection through official HO account

- Academic supervision
- Examination & evaluation
- Certification issuance

**Revenue Sharing:**

75% Franchisee : 25% Head Office

### **3. Academic Structure**

- Franchisee may submit course content/module for review.
- Final syllabus approval shall remain with Head Office.
- Classes shall generally be conducted once per week to accommodate working professionals.
- Minimum duration and academic standards shall be defined by Head Office.

### **4. Examination & Certification**

- Assessments and examinations shall be conducted under Head Office supervision.
- Final results shall be declared by Head Office only.
- Certificates shall be issued exclusively by OHM College of Astrological Sciences & Research Centre - Global with unique verification identification.
- Franchisee name shall appear as: *Authorized Learning Center (City Name)*.

### **5. Brand Usage Policy**

Franchisee shall operate strictly under the title:

**OHM College of Astrological Sciences & Research Centre - Global – Authorized Learning Center (City)**

Independent usage or modification of brand identity is not permitted without prior approval from Head Office.

### **6. Fee Collection Policy**

All student fees shall be deposited directly into the official Head Office account to maintain transparency, academic control, and certification authenticity.

### **7. Franchise Validity**

Franchise authorization shall remain valid for 3 Years from the date of agreement. Renewal terms shall be mutually reviewed upon completion of validity period.

### **8. Non-Transferability**

Franchise authorization is granted to the approved faculty/person only and shall not be transferred, sub-licensed, or assigned to any third party.
